Scarce 1795 \$1,000 Treasury Bond

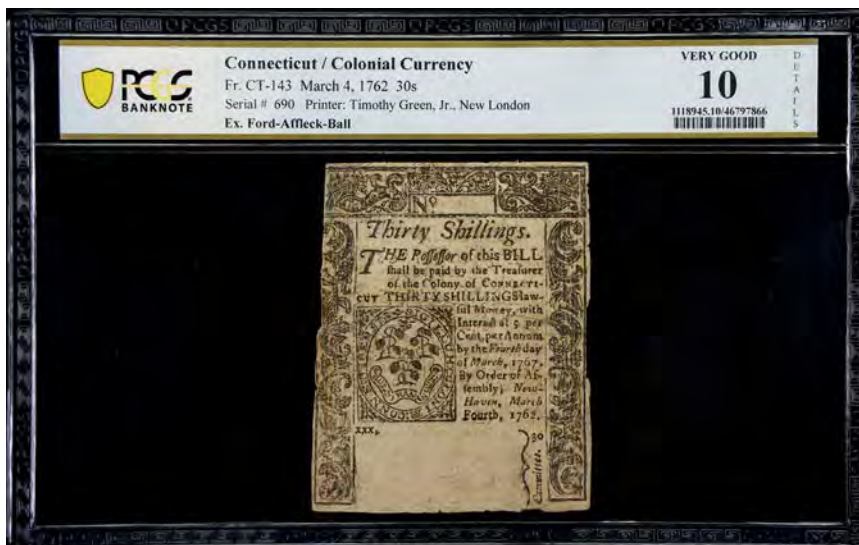

**\$1,000 Treasury of the United States Register's Office July 28, 1795 (1796) 5 1/2%. PMG Choice Very Fine 35.** This bond originates from an act passed by the inaugural United States Congress, which aimed to bolster public credit and address the redemption of national debt. Joseph Nourse, who served as General Charles Lee's military secretary during the Revolutionary War, affixed his signature to the document. In 1781, Nourse took on the role of the first Register of the Treasury, a position he held for an impressive 48 years until President Andrew Jackson relieved him of his duties in 1829. An intriguing aspect of this bond is the notary public seal of Robert Henry Dunkin for the Commonwealth of Pennsylvania, positioned at the bottom left. The bond measures appropriately 7.25 by 13 inches. It was issued to "Arthur Cramond & Co. of London, a merchant firm operating in England that filed for bankruptcy in 1797, two years after the certificate was issued. We know of only two others, and this is the first example we have handled. PMG comments "Pinholes, Splits".

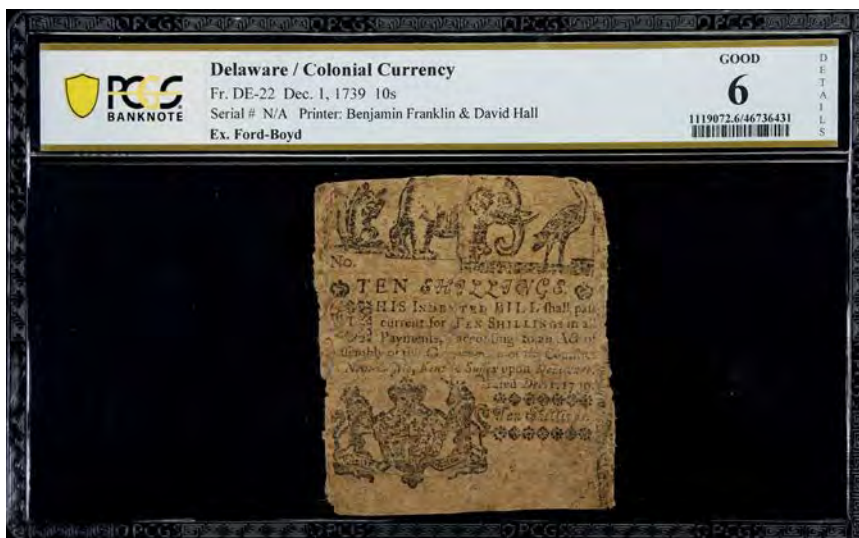

Back imprinted “New-London. Printed by Timothy Green M,DCC,LXII.” Ex: Ford-Affleck-Ball. PCGS Banknote cites “Multiple repairs, design redrawn.” A pleasing note overall despite its shortcomings. If this were a common note, it would be considered “filler” quality. However, this piece represents an opportunity for the advanced collector to obtain a rare note from an equally rare issue. It is far nicer than the qualifiers would suggest.

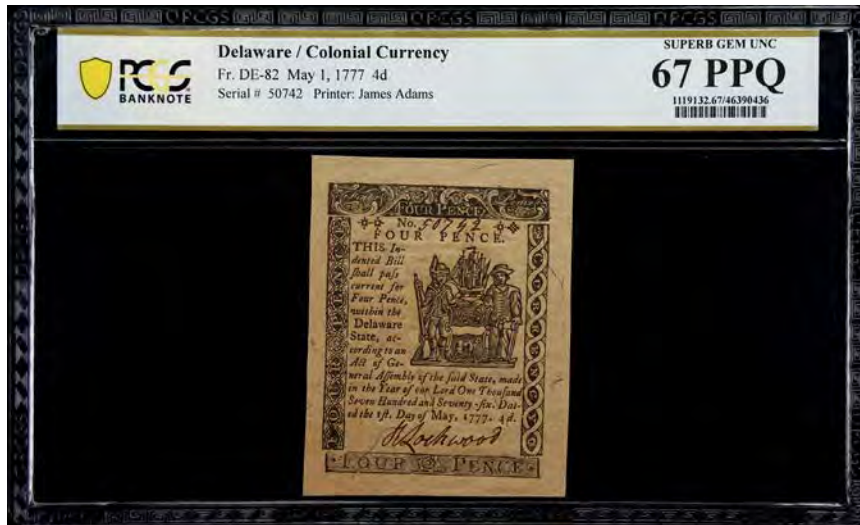

This is the highest denomination from this second Ben Franklin issue (the first was the 1734 series). Six Thousand Pound Sterling were authorized from this issue date to replace worn bills. PCGS Banknote cites Multiple Repairs, Reassembled. The eye appeal is better than that connoted by the Good 6 grade. A rare note from a rare pre-1750 colonial issue that should see heavy and spirited bidding before the hammer falls.

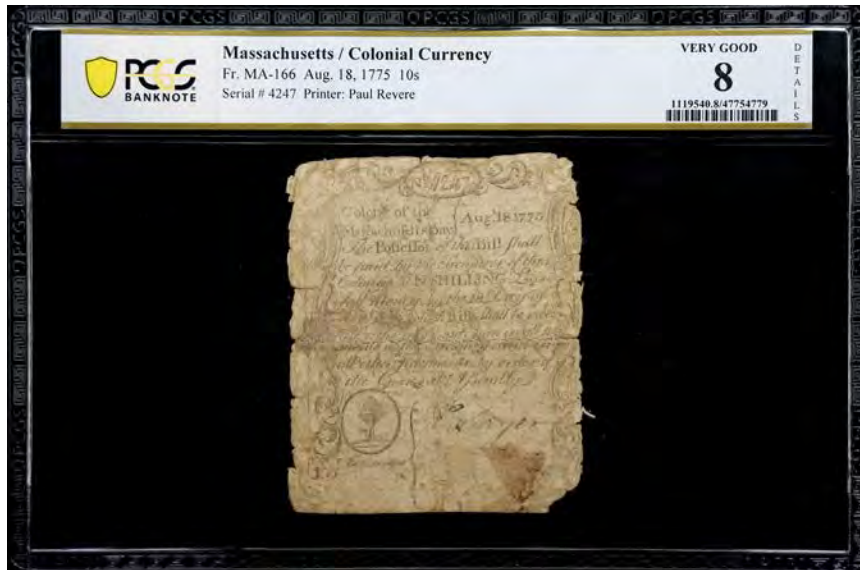

Signed by Thomas Leech, Samuel Smith, Monington, Harvey and Chapman. Printed face and back by Benjamin Franklin, his sole imprint B. Franklin on the back. Face with Penn Arms, obligation text within border frame with side column devices. The back with Nature Print leaf design by Franklin, counterfeit warning above, borders and ornaments around perimeter. An extremely important, if not the most important, B. Franklin imprinted currency note type. The first Pennsylvania series with Franklin's named imprint and Nature Print design, done by his own hand, although he printed notes for the Province earlier (without imprint). The Nature Print security device created by Franklin for this series was carried forward on the next several issues of notes and was in use on money well into the 1780s. As such, it is one of the most famous styles in all of Colonial paper money. The Nature Print was also used on New Jersey notes (the first Franklin series of March 25, 1737 from New Jersey is its earliest appearance) and the resolutions of Continental Currency. The note itself is in extraordinary condition and of the utmost rarity. We have seen only two examples from this enactment over two decades and have catalogued both of them. This is the Boyd Collection note and plated in all five editions of his opus. The solitary horizontal folding has no paper breaks whatsoever; there is some other minor handling seen under magnification. The penned signatures are all strongly accomplished for the ink types used. There are some subtle hints of faint foxing at the upper left and bottom edge of the back. The note is splendidly full with a wavy indent cut at the top edge. The clarity of printing is in the tradition of Franklin's meticulous standards of excellence as the face and back inks are evenly distributed. The Nature Print back is exceptionally sharp, exhibiting fabulous definition of an early plate state. This is the finest early Nature Print note made from plates both created and printed by Franklin's own hand. A currency note that exemplifies Franklin's creative genius in currency security printing that would continue for decades, one of the myriad contributions he made during the course of his long, illustrious life. Easily, among the giants of Colonial American currency types. Pedigree research conducted from June 2003 and throughout the Boyd-Ford Colonial project at Stack's yielded no auction offerings of any other notes from this 1739 Pennsylvania series. In fact, including Boyd, we have four 1690/91 Massachusetts Bay Bill of Credit auction records at hand over the past dozen years. This note series is clearly much, much rarer and passed as current money in wider circulation among the populace. The other example from this series known to us, also a 20 Shillings, was sold in the 2009 White Oak et al sale by Stack's in Baltimore. That note was laminated heavily in plastic on both sides and had once been bought on the bourse floor at a Strasburg show long ago." This is the finest of just a small handful known. It is far superior to the Newman note which was heavily repaired and graded PCGS Currency Apparent 12 and sold for \$12,000 in 2017. This problem free, attractive example will be a highlight in any colonial currency collection.

The back, printed coin turn, has a wider pattern border than the face. Different emblem than face left with Continental Currency top right, denomination right center, and imprint at the bottom right. Back emblem features ships on calm sea, with radiant sun shining above, encircled with motto CESSANTE VENTO CONQUIESCEMUS (When the storm dies down we will rest).

An absolutely riveting American paper currency note and one we believe is destined to attain legendary status. Within this exceptional collection of Benjamin Franklin related currency, there are many highlights. However, this Marbled Edge note type is the foundation from which to build an exceptionally elite American paper currency collection. Not only are the May 10, 1775 notes the first series of paper money authorized by the American Congress, they are forerunner of the Federal issued notes commencing in 1861 with Demand Notes. Appropriately, they are listed at the front of the Friedberg United States paper money standard text. Franklin's impact as a printing innovator with the Continental Congress series notes commenced with this uniquely styled type. Franklin furnished the marbled polychrome color paper used for the notes. This well crafted, unique paper type was an anti-counterfeiting device that Franklin would have greatly favored. This marbled paper also inspired Franklin to use a similar marbled paper for the United States loan certificates made near Paris to finance the American Revolution. Most importantly, he sketched the stirring face and back emblem designs and mottos used. Paired together, they were also used on the May 10, 1775 Session \$30 notes and three subsequent resolution's \$30 notes. This note is the finest 1775 Marbled Edge \$20 Continental extant by far. The paper quality is as made with only the tiniest corner bend visible. Tremendous natural embossing is seen on both sides in conjunction with razor sharp printing clarity. Fully margined face, though slightly skewed centering. The face to back registration is less than perfect from the back, a minor triviality in the big picture of the magnificence of this example. This museum piece exceeds the three notes sold in Ford VIII by leaps. As the census topper of such an illustrious early series of American notes, it seems fairly easy to make the case for this being a six-figure numismatic treasure. A tremendous opportunity to obtain the finest and most historic Continental Congress currency note, crafted in the greatest traditions of Franklin's innovative genius.” Nothing has changed since its last appearance. In the event any applicable conditions of these Terms of Sale herein are not complied with by a Buyer or if the Buyer fails to make payment in full by the Default Date, Stack's Bowers reserves the right, in its sole discretion, in addition to all other remedies which it may have at law or in equity to rescind the sale of that lot or any other lot or lots sold to the defaulting Buyer, retaining all payments made by Buyer as liquidated damages, it being recognized that actual damages may be speculative or difficult to compute, and resell a portion or all of the lots held by Stack's Bowers, in a commercially reasonable manner, which may include a public or private sale, in a quantity sufficient in the opinion of Stack's Bowers to satisfy the indebtedness, plus all accrued charges, and Stack's Bowers may charge a seller's commission that is commercially reasonable. More than one such sale may take place at the option of Stack's Bowers. If Stack's Bowers resells the lots, Buyer agrees to pay for the reasonable cost of such sale, together with any incidental costs of sale, including reasonable attorney's fees and costs, cataloging and any other reasonable charges.
