HAROLD SHAW BAREFORD

1894 - 1978



Harold Shaw Bareford was born April 21, 1894 in Millville, N.J., the youngest son of William Albert Bareford, master glass blower, and Mary Carey Shaw. He died suddenly at home on April 10, 1978 after spending a typically full day at his New York law office. High School valedictorian in 1912, he graduated in 1916 from Cornell Law School. During his college years he met Harriett Grace Hine, also a 1916 graduate, from Ithaca High School. They were married the following July.

He was commissioned in the Field Artillery at Plattsburg in November of 1917 and served until December of 1918. He joined the law firm of Thomas & Friedman and soon became a full partner. In 1920 they joined the legal staff of their client, Warner Bros. Pictures. In 1929 he was made General Counsel, Assistant Secretary and Director of Warner's. In 1943 he took a leave of absence to go on active duty as a Captain in the Coast Artillery. Discharged as a Major in 1945, he returned to Warner's, and on his retirement in 1959 he resumed full time private practice.

He was an active Mason and gave freely of his time to various charitable organizations. He was an avid hunter, fisherman and golfer nearly all his life.

Harold Bareford became a serious numismatist after the second World War and was a member of the ANA and the BNS, a fellow of the ANS and the RNS, and a member of the 1969 Federal Assay Commission. He was an officer from its inception of the Metropolitan New York Numismatic Convention, serving with such numismatists as Raymond Gallo, Vernon Brown, Martin Kortjohn and Edward Hessberg. He was also President of the New York Numismatic Club from 1959 through 1961. His presidential gold medal is appropriately the cover theme of this catalogue of his United States gold coins.

A SON WRITES ABOUT HIS FATHER

I think you might be interested in knowing a little more about how this extraordinary collection of United States gold coins was formed by my father, the late Harold S. Bareford. When he began systematically collecting coins at the end of World War II, my father recognized very clearly that gold coins of top quality were both extremely rare and grossly underpriced. With two exceptions, this collection was formed in the period from 1945 to 1951 when the coin market was actually in a decline. When prices began to advance after 1941, my father almost stopped purchasing gold coins, except for four lots from the Farouk Sale and five coins from the Davis-Graves Sale, both held in 1954.

Many collectors who today style themselves "condition freaks" were twenty years behind my father in appreciating quality. In 1947 he described the kind of a collection he was assembling to Paul Seitz in the following terms:

"I acknowledge receipt of your Mail Auction Catalog of May 7th, 1947, and am interested in a few items... Perhaps a word about myself is in order. I collect only the very finest specimens...and am not interested in any coin which is not perfect... I am enclosing herewith bids on a few of the coins based on the assumption that they are exactly that. If they have scratches or oxidation which affects the appearance on the face of the coin, or in any way are not perfect coins, I wish you to cross out my bid on such coins. To me a perfect brilliant proof...has no defects of any kind whatsoever, the same as gem uncirculated."

My father loved to display his coins at meetings and conventions, and to have what no one else had. He retained many of the original envelopes to preserve the history of his coins, but he coded purchase price information for privacy. He particularly liked to display his 1894 birth year set, with the Philadelphia coins all in Proof, and the branch mints in Gem Uncirculated condition.

Since he already had the \$1.00 and \$2.50 coins from 1875, he decided he would try to complete the set. Just to get the Proof 1875 half eagle he commissioned Abe Kosoff to buy from the Farouk Sale the 15 coin half eagle lot containing all dates and mints from 1871 to 1875. Dad's pattern gold dollars, the 1795 heraldic half eagle and three variations of 1820 half eagles also came from this sale. He was appalled, however, by the price and condition of some of the coins. Because he budgeted a fixed sum of money each year for coin purchases, he was frustrated for the first time in a collecting goal.

Then the Davis-Graves Sale came along with a complete set of 1862 Proofs. My father already owned an 1862 \$3.00 Proof, so he only needed five of the six coins for a long set. They were to be sold separately, or as a set to anyone who bid more than the combined prices. Inasmuch as my father would not buy duplicates, he threatened never again to do business with the Stack's if they sold the coins as a set. They didn't, and he had his long set, almost the last coins added to his collection.

In view of my father's exacting standards, he bought very few of the larger gold coins. They were rarely struck or preserved in the condition he desired. He concentrated on half eagles and smaller denominations. For example, he was able to assemble a remarkable and nearly complete collection of gold dollars. There are a few missing because he never found suitable specimens and would not buy inferior ones. His collection also contains a nearly complete set of Charlotte and Dahlonega quarter eagles and half eagles in gem condition, a spectacular run of \$3.00 coins and many exquisite Proofs in all denominations. There are as well such classic rarities as the 1795 half eagle with large eagle reverse, the 1848 "Cal." quarter eagle, the 1875 dollar, quarter eagle, and half eagle, and the 1933 eagle.

Careful study of this catalogue will show that no collection of half eagles has ever come on the market in which the average condition of the coins has been higher. This is all the more remarkable when you consider that dad bought no duplicates, and never sold or traded-up for a coin in better condition. Blessed with a photographic memory, he either bought exactly what he wanted and knew to be the best, or he didn't buy.

It might have been fitting to keep the Bareford Collection intact, or even to enlarge it, but my father abhorred the permanent removal of coins from numismatic circulation. Museums, in his opinion, were less apt to care for and preserve coins than individuals spending their own money on them.

The acquisition of these coins gave my father a tremendous amount of pleasure. It was his desire that they be sold at public auction after his death in order to give as many collectors as possible the chance to enjoy the coins as much as he had. He would have been as proud as I am, and as Stack's should be, of the job that has been done in photographing and cataloguing the collection. In so doing Stack's has provided a fitting memorial to the Bareford Collection.

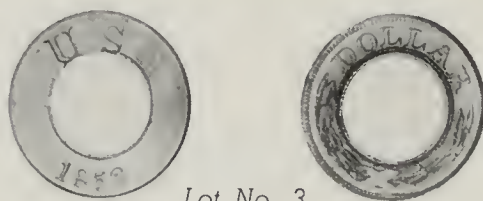

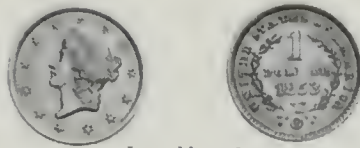

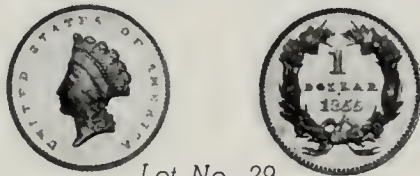

- 29 **1855 Brilliant Proof.** A sharply struck **gem** in deep yellow gold. Fully two-tone in appearance, some delicate cloudy toning. A beautiful coin of inestimable rarity.

David Akers, in his book on Gold Dollars, has compiled a list of appearances of an 1855 Proof at Public Auction. **He lists only 8 appearances since 1921.** Considering the fact that some of those offered were the same coin, e.g. the W.G.C. and the Memorable Collection (this specimen), it is our opinion as well as the estimate of others that **only 6 specimens exist.** To further amplify the importance of this coin (with all of the great collections we've sold), the last specimen we offered at Public Auction was at our Bell Sale in 1944. The last example offered at Public Auction nation-wide was at the Melish Sale in 1956 (over 20 years ago).

It is very difficult to place a value on the coin, however, we believe a bid in the mid-five figure range certainly is in keeping with other Proof gold of comparable rarity, bearing in mind that this is only a two-year type in Proof.

- 30 **1855 'C' Brilliant Uncirculated.** Frosty mint bloom with delicate coppery overtones. The reverse, as usual, is better struck than the obverse but it is, by far, better than normally encountered. The clash marks are lightly in evidence. The planchet is excellent and overall it is a very attractive coin. The date is fully struck-up. Of the four Mint State specimens recorded by Akers, we've sold three of them. This is the best of all and it could probably be the "Finest Known."
